




Wearing Instructions



Before getting started, please make sure the L and R marking on the earpiece is consistent with that on the cable (Blue on the L side and Red on the R side).




Grasp the earpiece and cable connector firmly and then attach the connector to the earpiece by straightly pushing the connector in until they click (if necessary, give it a little rotating force).





Identify the L (blue) and R (red) marking before wearing, and then adjust the cable and earpiece to the right angle.






Loop the cable around the top of your ear and then insert the earpiece into the ear, maintaining the correct angle for a secure and comfortable fit.





To detach the cable, grasp the earpiece and cable connector firmly and pull straight apart (if necessary, give it a little rotating force).



Please DO NOT insert or detach the cable with a tilted angle, it may damage the MMCX connector components.

Please DO NOT pull the wire to avoid fracture.

^{*} If you find it difficult to pull the MMCX connector out of the earpiece, please DO NOT pull them apart by violent force; if necessary, please reach out to our customer service.

Precautions

- 1. For your safety, please avoid using earphones in dangerous environments.
- 2. Please set the volume to a suitable level to protect your hearing.
- 3.Please do not expose your earphones to damp or strong magnetic environment for a long time.
- 4.If the unit is to be left unused for a long time, please unplug your earphones from the playing device.
- 5.Do not disassemble the earphones on your own.

Warranty Terms and Conditions

1 FiiO provides one-month direct replacement guarantee and one year of free maintenance for product against defectives in material and workmanship under proper operation. (You may be asked to provide proof of purchase for after-sales service, so keep your purchase invoice / receipt in safe place.)

Note: The warranty service is applied to authentic product brought from FiiO authorized sales agents with valid security code.

3 Checking result:

- A. The product you arechecking is genuine. The product is manufactured by FiiO Company, thanks for choosing us.
- B. The number you arechecking does not exist. The product is not manufactured by FiiO Company.
- C.The number has been checked. If this is the first time you enter the security code after scratched the coating personally, it means the product is not an authentic one.
- D. The security code you input is less than 20 bits, please try it again.
